 CHILDREN - ESWATINI CONTINUES TO SUFFER THE EFFECTS OF THE HIV/AIDS CRISIS, WITH NEARLY HALF THE POPULATION CLASSIFIED AS ORPHANS OR VULNERABLE CHILDREN. HEART FOR AFRICA PROVIDES A SAFE, LONG-TERM HOME AT PROJECT CANAAN FOR OVER 440 CHILDREN, MANY OF WHOM ARRIVE SEVERELY MALNOURISHED OR TRAUMATIZED. A NEW BABY IS RECEIVED APPROXIMATELY EVERY NINE DAYS. THE ORGANIZATION SUPPLIES HOUSING, NUTRITION, CLOTHING, HEALTHCARE, AND EDUCATION THROUGH HIGH SCHOOL, AS WELL AS VOCATIONAL TRAINING TO PREPARE CHILDREN FOR ADULTHOOD AND EMPLOYMENT.
